## 2011 CWWH AWARDS

#### **Armitage-Jameson Prize**

In 2011, Peter Boag, Charlene Porsild, and Karen Leong composed the committee that awarded the Armitage-Jameson Prize for best book about western women and gender history. The winner was Frontier Feminist: Clarina Howard Nichols and the Politics of Motherhood (Lawrence: University Press of Kansas, 2010) co-written by Marilyn S. Blackwell, an independent scholar, and Kristen T. Oertel, Mary Frances Barnard Associate Professor in Nineteenth-Century American History at the University of Tulsa. This outstanding biography traces the life of Nichols (b. 1810) from frontier New England to Kansas immediately prior to the Civil War and on to California where she died in 1885. Nichols challenged gender conventions of the era, dedicating herself to a multiplicity of reforms wherever she lived. Oertel and Blackwell donated half of their prize money to the Kansas Historical Society for a project that includes the digitizing of Nichol's papers. The award committee issued an honorable mention to Earning Power: Women and Work in Los Angeles, 1880-1930 (Reno: University of Nevada Press, 2010) by Eileen V. Wallis, assistant professor at California State Polytechnic University, Pomona. Peter Boag

#### Irene Ledesma Prize

The recipient of the 2011 Irene Ledesma Prize was Larisa Veloz. Veloz is a Ph.D. Candidate at Georgetown University. Her project, entitled "Forgotten Migrants: Mexican Women and Migrant Families, 1930-1965," impressed the committee with its contributions to a growing field of scholarship on Mexican and Mexican American women. She focuses on women and children as migrants, and addresses their agency as they worked to form communities in the United States and in Mexico. She strives to add migrant women to the maledominated narrative of migrant workers, and to shed light on transnational families, those who had multiple citizenship and residency statuses. She plans to use the funds from the Irene Ledesma Prize to further her research on personal papers and photographs to gain a greater understanding of the women's labor experiences and of agricultural history. #### **CWWH Roundtable**

In honor of Western History Association's semi-centennial (1961-2011), and as western states celebrated their one hundredth birthdays of woman suffrage-Washington (2010), California (2011), and Oregon (2012)—the Coalition for Western Women's History Roundtable asked the question: "What Difference Did Woman Suffrage Make?" Par-

ticipants considered the significance of the franchise from a variety of different perspectives, from its impact on women as political actors, to the meaning of political power for women of color, to the ways that newly enfranchised women affected-or failed to affect-the political sphere. Discussants included authors and editors of Women and Politics: California from the Gold Rush to the Great Depression (University of Nebraska Press, 2011): Robert W. Cherny, Sue Englander, Rebecca Mead, Scotty Hopkins, and Mary Ann Irwin. Mary Ann Irwin

# CWWH at the 2011 WHA, cont.

**CWWH Branded Session:** 

"The Legacy of Women and Gender in Public History: New Careers, Voices, and Perspectives in Western History"

For the past fifty years, women active in the Western History Association used their careers in western history to push the boundaries of public history—and vice versa. When the WHA Annual Conference celebrated its 50th Anniversary in Oakland last fall (2011), several women from the field of public history gathered for a session where they addressed recent developments in the profession and how women and gender are included and interpreted through various public history projects. Over fifty people attended the session. Session participants included Janet Fireman (California History and USC) and Virginia Scharff (UNM and Autry National Center), leading figures in public history and comoderators for the event. Panelists included: Leslie Working (ABD, UNL), who shared her insight into the growing field of digital history

and how women's participation in the conceptualization of institutional online projects may help offset the common gender imbalances; Kristin Ahlberg (U.S. Department of State) discussed how issues of gender influence public history projects carried out in her career as an employee of the Office of the Historian; Sonia Dickey (Lore of the Land, Inc.) revealed the gendered discussion threads that have appeared through interviews with ranchers, farmers, miners, indigenous people, and historians from Canadian and Pecos River watersheds in the American Southwest: Dorothea Crosbie-Taylor (Oakland Museum of California) shared how a new exhibit, "Forces of Change," influences the ways that the public interprets the study of women and gender in Oakland's history. Finally, Leisl Carr-Childers (NAU) provided an overview of how her work for the Nevada Test Site Oral History Program and Teaching American History grants broadened her professional and public history experiences. 


Kathleen Underwood (above) received the 2011-12 award for Outstanding University Service at Grand Valley State University. In

# **ARMITAGE-JAMESON PRIZE**

The Coalition for Western Women's History is pleased to announce the third-annual Armitage-Jameson Prize for the most outstanding monograph or edited volume published in western women's and gender history in 2011. This award honors the pioneering work of historians Susan Armitage and Elizabeth Jameson.

Deadline for submission: May 15, 2012

The CWWH will award \$1000 to the author of the winning book, and the press will receive a certificate. To be eligible, the book must be published in 2011 and address the history of women and gender in the North American West, which includes the relevant geographic regions of Canada and Mexico, as well as United States territories, past and present. We encourage authors and presses to think about the history of women, gender, and sexuality the North American West in an expansive way. Nominations are especially encouraged that push the boundaries of our field by examining such topics as sexuality and transgendered history, urban spaces, racial and ethnic communities. For example, books do not have to solely focus on famous western women, but might focus on how shifts in labor relations in western states affected gender relations or family structure, the relationship between masculinity and western politics, gendered analysis of the west in the national imagination, or even an intersectional analysis on how women from of different ethnic and racial backgrounds in the west negotiated social shifts in the 20th century, including the social movements of the 1960s or Cold War politics.

The award will be presented at the CWWH Breakfast (held during at the 2012 Western History Association annual meeting in Denver, Colorado, October 4-7).



# The Coalition for Western Women's History announces the 14th Annual Irene Ledesma Prize, 2012

For Ph.D. graduate student research in western women's history.

Deadline for submission: May 1, 2012.

The \$1,000 prize supports travel to collections or other research expenses related to the histories of women and gender in the American West. Applicants must be enrolled in a Ph.D. program and be members of the Coalition of Western Women's History (CWWH) at the time of application. The prize honors the memory of Irene Ledesma, whose contributions to Chicana and working-class history were ended by her untimely death in 1997.

The CWWH will award the prize at the CWWH Breakfast during the 52nd Annual Western History Association conference at Denver, Colorado, October 4-7, 2012.

Proposals will be evaluated according to the following criteria:

- How well the applicant stated her or his research question and the significance of the overall project.
- How well the applicant demonstrated her or his knowledge of the primary source materials related to the proposal.
- How well the applicant framed her or his project in terms of the broader theoretical and historiographic issues significant to the topic.
- How well the proposal addressed issues of gender and/or women's history in the U.S. West.
- How well the proposed budget dovetails with the applicant's stated research agenda.

To apply, submit one copy of each of the following (as a PDF file) to each committee member at the email addresses listed below:

- A CV
- A brief description of the research project and an explanation of how the prize funds would support the research (not exceeding three pages, double spaced, addressing the criteria)
- A line-item budget
- A letter of support from the student's major advisor


