

### From the Steering Committee Chair

Hi everyone!

As many of us prepare for next month's WHA 53rd Annual Conference in Tucson, I want to highlight\*\*\* (note the three asterisks) several CWWH conference activities. Since this year marks the 30th Anniversary of the Coalition for Western Women's History, we planned a roundtable session to discuss the organization's history and development of western women's history, more generally. The title of the panel is "From Sun Valley to Tucson: Three Decades of Growth in Western Women's History." As many of you know, the idea for the CWWH arose after a group of women's historians met at the "Inventing the West" Conference in 1982. From this gathering, the participants formed a Steering Committee and planned to hold a conference the following year: the legendary Women's West Conference of 1983, held in Sun Valley, Idaho. Sandy Schackel is chairing the session which includes Joan Jensen, Kathleen Underwood, Paula Petrik, Susan Armitage, Elizabeth Jameson, Elliott West, and Mary Murphy. I'm calling it ahead of time: This is going to be a fantastic panel and one of the conference's best. I also want to announce a time change for the CWWH business meeting—it is now scheduled for 4:00-5:30, Wednesday, October 9 (after the CWWH roundtable).

The Coalition's "branded session" is being held on Friday, October 11. Renee Laegreid is chairing the session which focuses on women and medicine in the American West. On Saturday, the CWWH is co-sponsoring with the Committee on Race in the American West (CRAW) a panel titled "The History and Legacy of Chicana Feminism and Activism in the American Southwest" (as an aside, what is with Word not recognizing the word Chicana?). The Coalition helped fund (with the UA History Department) a shuttle bus to transport WHA attendees to the "Tucson Meet Yourself: A Folklife Festival" in downtown Tucson for the CRAW session: "Showdown on the Border: Civil Discourses in Uncivil Times: Why Does Ethnic Studies Matter for Western History?"

If you haven't done so already, consider giving support to the Graduate Student Meal Fund (GSMF). The program allows you to provide monetary support for graduate student meals during the conference. Also, please contribute an item to the Coalition's Silent Auction; monies raised by the Silent Auction help fund the Armitage-Jameson Prize and the Irene Ledesma Prize. ### Elizabeth Jameson: WHA President-Elect

I am descended from a long line of strong and stubborn women. Both of my grandmothers were social workers. My mother's mother, Rose Klein, worked to get hot lunches in the Austin schools, and then agitated for hot breakfasts. My father's mother, Esther Jameson, ran Jewish Social Services in Newark while raising four children on her own, one of whom had Down's Syndrome. My mother graduated from medical school in 1949, two years after I

was born, and practiced psychiatry until she finally retired at age 80. I was fortunate to have these women in my life in the 1950s, to know that my only choice about college was where to go, to be told early and often that I should achieve all that I could.

I was fortunate, too, to come of age with the Women's Liberation Movement and to enter graduate school in the early 1970s. I got to assist Kathryn Kish Sklar's first



women's history class at the University of Michigan and to be part of a collective of women professors and graduate students who taught the first introduction to women's studies course there. From 1972-1976 I helped establish the women's studies programs at the Universities of Michigan and Colorado and helped found *Michigan Papers in Women's Studies* and *Frontiers: A Journal of Women Studies*. In 1974, while I researched my dissertation in Boulder, I met Sue

Armitage, my friend, colleague, and writing partner for now almost 40 years. With Sue, Melissa Hield, Paula Petrik. Pat Albers. and more other wonderful colleagues than I can name, I was privileged to help organize the first Women's West conference in 1983, and to co-found the Coalition for Western Women's History. The CWWH has anchored my most enduring and important group of colleagues and collaborators.

So mostly I want to thank all of you for years of criticism, questions, friendship and support. I know that I owe my nomination as President-Elect of the WHA to more of you than I know, and especially to Mary Murphy, Renee Laegried, Dee Garceau, and the intrepidly stubborn Lori Ann Lahlum, who had the idea and organized to make it happen. Thank you all more than I can say.

### Cynthia Culver Prescott: for Steering Committee

Cynthia Culver Prescott is an associate professor of history at the University of North Dakota. She is the author of Gender and Generation on the Far Western Frontier (University of Arizona, 2007), and has also published on pioneer monuments and western quilts. She has served on the CWWH Irene

Ledesma Prize committee and in CWWH writers groups.



## Catherine Lavender: for Steering Committee



I was born in Northern California, the descendant of gold miners and their widows. After living in Alaska, California, and Washington, DC, my family settled down in Denver, Colorado, which I still think of as home. I completed my PhD in western and women's history at the University of Colorado at Boulder, where I studied with Patty Limerick and Lee Chambers. In

1996, I moved to Staten Island, NY, the outermost of New York City's outer boroughs, to take a tenure-track job; I am now an associate professor of history and the Director of the American Studies Program at the College of Staten Island/CUNY. At CSI/ CUNY, I enjoy teaching students who do not initially know the difference between a steer and a bison about the West, mostly by analogy to their own status as the outermost outer borough. My dissertation became Scientists and Storytellers (UNM Press, 2006), which is a study of feminist ethnography in the American Southwest in the first half of the twentieth century. I am currently working on a book about the Western Apache religious leader Silas John Edwards. I served on the CWWH's board in the mid-1990s, and am currently a member of the committee which plans the CWWH roundtable.

### Jennifer Macias: for Steering Committee



I completed my bachelor's degree in history at Colorado State

University. I am currently a PhD candidate in the History Department at the University of Utah. My major field of interest is United States history, while my minor fields include Latin American history and Latino/a history in the United States. My dissertation project focuses on Latino/ a families in the Rocky Mountain West Region from 1945-1965. I am particularly interested in the ways in which Latino/a families interpreted the idea of an "American Dream" in the post-World War II era, and the ways in which a Latino/a Rocky Mountain West identity changes our understanding of the significant role that Latino/as have played

in the second half of the twentieth century in the United States. I am currently teaching a number of classes, which include Women in America. American Indian History, and United States history from colonization to the present. I also serve as the president of Utah's History Graduate Student Association where I have spent considerable time increasing graduate student involvement in the culture of the department. My goal as a steering committee member would be to increase grad student participation in CWWH.

### Leslie Working: for Steering Committee

While at the University of Nebraska-Lincoln, Leslie Working has finished master's degrees in museum studies and history and is nearly finished with her dissertation: "Good Soil for Reform: Gender, Mobility, and Activism on the Great Plains." Leslie has also spent her time at UNL as a student worker and project manager on Digital History projects, including Envisaging the West and Railroads and the Making of Modern America. She has worked on the WHA's Technology Taskforce for the past four years and is always willing to offer ideas, advice,

and a sounding board for folks



working on digital projects. As a member of the CWWH, she has really enjoyed her three years spent on the Auction Committee. When not working or traveling, Leslie is likely to be found doing yoga, hiking the gentle slopes that pass for hills around Lincoln, watching the Turner Classic Movies channel, or indulging a regrettable appetite for dark, twisty mystery novels.




