### From the Chair: Cathleen Cahill

Dear Coalition Colleagues,

Welcome to the 63<sup>rd</sup> Annual Conference of the Western History Association!



I'm looking forward to seeing many of you in sunny LA! As

you peruse your program, you'll note that the CWWH has been successful in helping to make many of the changes we hoped to see in the WHA. The conference will welcome a new president, **Dr. Kelly Lytle Hernández**, who will be the fourteenth woman to serve in that position in the WHA. **Mary Lee Spence** of the University of Illinois Urbana-Champaign was the first woman elected to the WHA presidency, serving in 1981-82. In her WHA oral history, Dr. Spence remembered that a **breakfast of female members** was held before the conference started where they discussed women in the organization and problems as they saw them. Still, they also had a lot of fun. Sounds familiar.

This year's program has several panels and papers featuring the topics of women, gender, and sexuality (and intersectionality) in the North American West. In some sessions, choosing which overlapping panels to attend will be hard, but it is a good problem. The Coalition has played a large part in these successes, but that doesn't erase the other issues our profession faces (and may be connected more broadly). We look with horror as West Virginia University and others gut their liberal arts programs. The attacks on books and history curriculum in elementary and secondary schools are also chilling. At the same time, the ousting of scholars at the Texas State Historical Association hits too close to home. Is it a surprise that these attacks have occurred as more women and scholars of color have entered the academy? What we do continues to matter.

I am proud to work with the incredible members of the Coalition who keep asking questions about our past that help us think about a more just future.

This year, our Wednesday Roundtable considers "50 More Years of Title IX" by looking back on that legislation's successes and weaknesses with a fantastic panel of practitioners, scholars, and journalists. The discussion is sponsored in conjunction with WHA CARES (Committee on Assault Response and Educational Strategies). We continue to prioritize mentorship and support for scholars working in the fields of women, gender, and sexualities, as demonstrated by this year's sponsored session, "Restoring Scholarly Community through Mentorship in a Post-Pandemic World," on Friday afternoon. Our mentorship also includes our visible presence at the conference and openness to making new participants feel welcome, which is a not-sosubtle reminder to please sign up for a turn at the Coalition booth! (The Google link is included here in the newsletter). Also, join us for the CRAW/Coalition reception. I challenge you to introduce yourself to at least one person you don't know and tell them about the Coalition if they aren't familiar with it. And finally, we remain committed to financially supporting young scholars with our prizes--come find out about this year's Ledesma Prize and the Conference Travel Grant winners at the Coalition breakfast on Friday morning! They are the future of the Coalition.

And yet, our successes have perhaps left us somewhat directionless. It has been harder and harder to fill our committees - in part because the number of committees addressing similar issues has expanded due to the hard work of members of the Coalition to make the WHA and our home institutions recognize the importance of these issues. Finding volunteers for our governing positions is harder as other positions have become open to women. And I am conscious that the economic hardships faced by public history institutions and the shrinking of departments in terms of tenure-track scholars and graduate admissions, as well as funding for all, has meant that fewer people are attending scholarly conferences and joining organizations. These trends beg the question of what we in the Coalition should be doing, where we should put our energy, and how best to continue supporting our mission while evolving to meet these new challenges. I urge you to encourage new members to join the Coalition! I invite you to send me your ideas, or better yet, join us for our business meeting on Thursday at 1:30 pm and share them there. Everyone is welcome, and

together, we can continue to be a force for good in the field.


## Member News

**Michelle Martin** joined the faculty in the Department of History at **Northeastern State** 



Gendered Advocacy and Activism, Shaping Institutions and Communities -

<u>Rural Women's Studies Association</u> Triennial Conference

Hosted by Arkansas State University, Jonesboro, Arkansas, USA, May 15-19, 2024

Recent challenges to civil rights in various locations internationally bring to mind equity in rural communities which has a separate set of challenges to those of urban areas. Yet, historically activism rooted in rural areas can result in broader change on both regional and national levels. Challenges activists face in pursuing change include a conglomeration of isolation, underfunded education, failing infrastructures, geography, poverty, demographics, lack of health care, low employment, and low wages. Rural activists then require focus and approaches that address their specific needs. In Worlds Apart, attorney and civil rights advocate, Angela Glover Blackwell stated, "equity is the antidote to the plight of isolated, disinvested communities...including rural communities."

Do activists focus on equity as a goal?

In consideration of recent events and movements, the theme of the 2024 Rural Women's Studies Association conference, Gendered Advocacy and Activism, Shaping Institutions and Communities, emphasizes the central role that women and individuals of all genders and sexualities have played and continue to play in shaping and reforming our institutions and communities. This potentially includes the exploration of such subthemes as: advocacy, education, agriculture, health, reproductive rights, mental health, LGBTQIA+, politics, poverty, race, ethnicity, religion, and Women's Rights issues.


### THE CWWH Booth Committee Need You!

SEATTLE, WA— Throughout the twentieth century, New Mexico's LGBTQ+ residents inhabited a wide spectrum of spaces, from Santa Fe's nascent bohemian art scene to the secretive military developments at Los Alamos. Shifting focus away from the urban gay meccas that many out queer people called home, Wide-Open Desert brings to life a vibrant milieu of two-spirit, Chicana lesbian, and white queer cultural producers in the heart of the US Southwest.


Jordan Biro Walters draws on oral histories, documentaries, poetry, and archival sources to demonstrate how geographic migration and creative expression enabled LGBTQ+ people to resist marginalization and forge spaces of belonging. Significant figures profiled include two-spirit Diné artist Hastíín Klah, literary magazine editor Spud Johnson, ranchera singer Genoveva Chávez, and Cherokee writer Rollie Lynn Riggs. Biro Walters explores how land communes, art circles, and university classrooms helped create communities that supported queer cultural expression and launched gay civil rights activism in New Mexico. Throughout, Wide-Open Desert highlights queer mobility and queer creative production as paths to political, cultural, and sexual freedom for LGBTQ+ people.

Jordan Biro Walters is associate professor of history at the College of Wooster.



To many Americans in the nineteenth and twentieth centuries, the West was simultaneously the greatest symbol of American opportunity, the greatest story of its history, and the imagined blank slate on which the country's future would be written. From the Spanish-American War in 1898 to the Great Depression's end, from the Mississippi to the Pacific, policymakers at various levels and large-scale corporate investors, along with those living in the West and its borderlands, struggled over who would define modernity, who would participate in the modern American West, and who would be excluded.


In Making a Modern U.S. West Sarah Deutsch surveys the history of the U.S. West from 1898 to 1940. Centering what is often relegated to the margins in histories of the region—the flows of people, capital, and ideas across borders—Deutsch attends to the region's role in constructing U.S. racial formations and argues that the West as a region was as important as the South in constructing the United States as a "white man's country." While this racial formation was linked to claims of modernity and progress by powerful players, Deutsch shows that visions of what constituted modernity were deeply contested by others. This expansive volume presents the most thorough examination to date of the American West from the late 1890s to the eve of World War II.

Sarah Deutsch is a professor of history at Duke University. She is the author of Women and the City: Gender, Space, and Power in Boston, 1870–1940 and No Separate Refuge: Culture, Class, and Gender on an Anglo-Hispanic Frontier in the American Southwest, 1880–1940.





## This Land Is Herland

Gendered Activism in Oklahoma from the 1870s to the 2010s

Since well before ratification of the Nineteenth Amendment in 1920 secured their right to vote, women in Oklahoma have sought to change and uplift their communities through political activism. This Land Is Herland brings together the stories of thirteen women activists and explores their varied experiences from the territorial period to the present. Organized chronologically, the essays discuss Progressive reformer Kate Barnard, educator and civil rights leader Clara Luper, and Comanche leader and activist LaDonna Harris, as well as lesser-known individuals such as Cherokee historian and educator Rachel Caroline Eaton, entrepreneur and NAACP organizer California M. Taylor, and Equal Rights Amendment (ERA) champion Wanda Jo Peltier Stapleton.

Edited by Sarah Eppler Janda and Patricia Loughlin, the collection connects Oklahoma women's individual and collective endeavors to the larger themes of intersectionality, suffrage, politics, motherhood, and civil rights in the American West and the United States. The historians explore how race, ethnicity, social class, gender, and political power shaped—and were shaped by—these women's efforts to improve their local, state, and national communities.

Underscoring the diversity of women's experiences, the editors and contributors provide fresh and engaging perspectives on the western roots of gendered activism in Oklahoma. This volume expands and enhances our understanding of the complexities of western women's history.

Sarah Eppler Janda is Professor of History at Cameron University in Lawton, Oklahoma, and the author of Beloved Women: The Political Lives of LaDonna Harris and Wilma Mankiller and Prairie Power: Student Activism, Counterculture, and Backlash in Oklahoma, 1962-1972. Patricia Loughlin is Professor of History at the University of Central Oklahoma in Edmond and the author of Hidden Treasures of the American West: Muriel H. Wright, Angie Debo, and Alice Marriott. Renée M. Laegreid, series editor, is Professor of History at the University of Wyoming.

> Janda and Loughlin are currently writing an Oklahoma history textbook to be published by the University of Oklahoma Press and offered for adoption in the state's high schools in 2025–26.

## Coalition for Western Women's History Lifetime Achievement Award

The Coalition for Western Women's History Lifetime Achievement Award recognizes outstanding service to the CWWH, first and foremost, as well as significant scholarship and advocacy in and for the fields of western women's and western gender history.

#### Criteria for the award:

- 1. Outstanding service to CWWH (including but not limited to holding offices, serving on the Steering Committee, membership on CWWH committees, organizing CWWH sessions at the WHA and other conferences, participating in CWWH sessions at the WHA or other conferences, participating at the annual business meeting) over a period of at least 20 years.
- 2. Contributing to our understanding of western history through western women's or western gender history, broadly construed. Contributions may include serving as an editor/associate editor of a journal or publishing house in the field of western women's or western gender history; editing and publishing firsthand narratives in the field; publishing original research in the field subject to juried peer review; organizing conference sessions within the field; and speaking to public media about the field.

#### Award:

- 1. Lifetime membership in the CWWH.
- 2. Certificate.
- 3. Donation to the WHA Graduate Student Meal Fund in the name of the recipient.

#### Selection of recipients:

- 1. An ad hoc committee consisting of two members of the Steering Committee may select one recipient after the inaugural selection. An award does not need to be given yearly; indeed, because of the small size of the organization, it is not advisable to give the award on a yearly basis.
- 2. The ad hoc committee can request a list of 20+ year members from the secretary.

3. If the ad hoc committee selects a recipient, the name is passed on to the Steering Committee Chair.

#### Before CWWH Breakfast (if a recipient is selected):

- 1. The Recorder and Treasurer are contacted so lifetime membership can be noted in the official records. The Treasurer cuts a check for the donation in the recipient's name to the WHA Graduate Student Meal Fund and sends the check to the WHA office.
- 2. The ad hoc committee prints and brings the award certificate to the breakfast.

If you'd like to nominate someone for the Lifetime Achievement Award, please follow the protocol and send forth your nominations!

#### **CWWH Breakfast**

1. The award is made at the annual CWWH breakfast at the Western History Association annual meeting.

#### After the Breakfast

- 1. The committee writes up a story for inclusion in the spring CWWH newsletter and submits the story to the editor.
- 2. The committee sends the name of the recipient to the webmistress for inclusion on the webpage.
